You will be notified whether or not you have been selected to participate within 30 days of receipt of your application. If you are not selected, your uncashed check will be returned. NO refunds or cancellations after October 1, 2010. Any applications received after August 15, 2010 will be charged a late entry fee of an additional \$25.

Although we anticipate receiving applications from vendors that have participated in the past, we are constantly seeking new applicants so that this year's event will have the highest quality of merchants. Vendors will be charged a flat booth fee (booth fees listed on application), but will not be required to donate an item for our silent auction this year. However, we would welcome any merchandise donation. You will receive an acknowledgement for tax purposes, for any merchandise donated to the auction.
